Who are the NVQ's for? These awards are work oriented qualifications and are suitable for those who work as an administrator, team leader or manager for over 2 days a week. Places are free but are limited and will be allocated on a first come first served basis, after an initial assessment of individuals development needs.

What will it involve? This is a very flexible way to learn new things and gain a qualification; it is delivered on a 1 to 1 basis by an allocated assessor. It will involve you producing evidence of your work, submitting it to agreed deadlines, and meeting with your assessor regularly either at VAB or at your place of work. The programme will start in August 2008 and run to end of May 2009.

Introduction to the Barnsley LINK (Local Involvement Network)

Thursday 25th September 2008

10:30 – 1:00pm

As part of a number of measures which aim to achieve better health and social care by giving people and communities a stronger local voice, a new system of 150 Local Involvement Networks is currently being set up.

The role of each network will be to find out what people want from local services, to monitor and review the care provided and to tell those who run and commission services what the community thinks.

The LINK will also have certain powers, including the power to 'enter and view' specific services, to make recommendations to commissioners and to refer matters to the local Overview and Scrutiny Committee.

It is expected that membership of the LINK will consist of a core set of committed members with additional participants who may choose just to be involved with the issues that matter most to them. Individuals and groups (including charities, community groups, faith groups and independent organisations) can all join the LINK.

In Barnsley the LINK will be hosted and supported by a partnership of Barnsley Arena, Voluntary Action Barnsley and Barnardos.

The 1st meeting for people who are interested in being part of the Barnsley LINK will be held Thursday 25th September 2008, 10:30am – 1pm, further details will be circulated shortly.

FUNDING

Grant Funding Opportunities to Support Coalfield Regeneration

The Coalfields Regeneration Trust's fourth funding programme commenced on the 1st April 2008 and will end on the 31st March 2011.

The Trust operates two grant programmes and is interested to hear from organisations who can deliver projects that fit with at least one of the following four themes:

Access to Employment

Preparing individuals for work and work experience by connecting them to employment opportunities by using existing agencies and programmes. Pilot schemes and network developments would also be considered if they were clearly additional.

Education and Skills

Encourage a return to work, first steps to learning, raising aspirations, improving skills and qualifications levels and providing accredited training over and above statutory duty.

Health and Wellbeing

Community based schemes that encourage a healthier lifestyle by preventing ill-health and promoting self help and support groups.

Access to Opportunities

Access to services and opportunities by addressing recognised barriers, childcare provision, benefits advice, money management and debt reduction schemes, credit union development, geographical isolation and community transport schemes.

Bridging the Gap

A Bridging the Gap grant can contribute towards eligible capital and revenue costs of a project for up to 12 months. It can contribute up to 100% of the total project costs, or a maximum of £10,000 to a larger project costing no more than £100,000 as long as the match funding package is complete. Voluntary organisations and community groups can apply.

Main Grants Programme

The Main Grant Programme is targeted at projects benefiting coalfield communities that are within the most deprived 30% in the country based upon the Government's Indices of Deprivation 2007. A grant can contribute towards revenue and/or capital costs to an overall maximum of **£300,000**. Voluntary organisations, community groups and statutory organisations can apply.

Europa Nostra Awards (Cultural Heritage)

These Awards are awarded annually to:

- identify and promote best practices in the conservation of tangible cultural heritage;
 - stimulate the exchange of knowledge and experience throughout Europe;
 - enhance public awareness and appreciation of European cultural heritage;
- further encourage exemplary initiatives through the power of example.
Outstanding heritage achievements will be awarded in the following categories:

Category 1: Conservation.

Category 2: Research.

Category 3: Dedicated service by individuals or organisations.

Category 4: Education, training and awareness-raising.

The Awards consist of two levels: up to six entries will be awarded a Prize which includes a monetary award of EUR 10,000, and up to 25 entries will be awarded a Medal.

Entries may be submitted from all European countries, by anyone closely connected with the entry, as long as the permission from the owner of the building or site, author of the study, or nominee has been obtained prior to submission.

The 2008 deadline for the receipt of applications is 1 October.

Awards for Excellence in Recycling

Entries are invited for the 2008 Awards for Excellence in Recycling and Waste Management.

There are nine categories in total, including the following:

- High Street Recycling Champion.

Applicants may enter more than one category; however, each individual entry can only be submitted for a maximum of two categories. Entry requirements include the submission of a 500-word summary of how the entrant(s) have achieved their success. Entries should be mainly based on the period April 2007 to March 2008.

Innovative Geography Teaching Grants

The Royal Geographical Society has five grants of up to £800 each to fund innovative geography teaching at secondary level, to enable imaginative, innovative or creative teaching materials and teaching methods to be developed. The aim is to serve both geography pupils and the wider teaching community throughout the UK.

All secondary geography teachers and trainee teachers can apply for a grant. Trainee teachers must be actively undertaking their course. At least one grant will be prioritised for NQT and trainee applicants and a further grant prioritised for applicants who are Members, Fellows or whose Institution is an Educational Member of the Society.

The King's Fund - IMPACT Awards

GlaxoSmithKline's IMPACT Awards are designed to recognise and reward charities that are doing excellent work to improve people's health. They are managed by The King's Fund, a leading independent health charity.

- * The awards are open to registered charities that are at least three years old, working in a health related field in the UK, with a total annual income between £10,000 and £1 million.
- * Nine winners receive £25,000 and an overall winner receives £35,000. Organisations that are highly commended or runners up receive £5,000 or £3,000.
- * You do not need to present a new project. The awards are designed to recognise success and achievements for existing work.
- * You decide how to use the award money.

Grants for the Arts

Arts Council England has issued its new guidance material for applications submitted 20 May onwards. Individuals and organisations (i.e. artists, performers, promoters, arts organisations, local authorities etc) are eligible to apply for funding for time-limited arts-related activities including:

- projects and events;
- research and development;
- education activities;
- bursaries;
- organisational development;

Supported activities should generally last up to three years and should engage people in England in arts activities, or help artists and arts organisations in England to carry out their work. Grants to individuals range from £1,000 to £30,000, and grants to organisations range from £1,000 to £100,000. **Application may be made at any time.** <http://www.artscouncil.org.uk/>





Local Authority Support Programme (England)

The Local Authority Support Programme, which offers operational, communications and waste prevention advice, skills training and limited funding for local communications activities to Local Authorities in England, opened to applications this month. A total of £6.5 million is available for 2008/09, of which around £3 million is likely to be allocated for local authority communications activities for the period to March 2009. In order to use its resources in a targeted way, WRAP has identified the following priorities for support:

- Improving the use of existing infrastructure – better capture, better quality, less contamination.

- Introducing food waste collection services.

Waste prevention including food waste prevention.

In addition, the programme is focused on the following three priority areas:

- Recycling.
- Food waste.

Waste prevention.

There is no deadline for submission of requests for support. However, the funding is linked to specific financial years, and WRAP needs to ensure that allocations of resources are made in good time to complete work within the financial year.

Early applications are encouraged from authorities that wish to be considered for communications funding, and WRAP expects to be reaching decisions on these requests from June 2008. Funding allocated for 2008/09 communication activities must be spent by late February 2009. <http://www.wrap.org.uk/>

New £1m Tender Fund launched

Futurebuilders England has launched a new interest-free loan fund for third sector organisations struggling to meet the cost of tendering for public sector contracts. The £1m Tender Fund is intended to help third sector providers win contracts where prohibitive tendering costs would otherwise make it difficult for them to bid.

Jonathan Lewis, Chief Executive of Futurebuilders England said: "We know there are organisations with the skills to bid for and win public sector contracts who simply can't afford the costs involved in preparing competitive bids. Our conversations with the sector tell us that providers often need money to fund tendering related costs such as legal bills, financial expertise, staffing backfill and advice from procurement specialists. We want to be as flexible as possible with the finance we offer and respond to the sector's needs, so we set up this fund specifically to help address this problem. The new Tender Fund will provide interest-free three year loans of between £3,000 and £50,000.

This will help organisations who simply need a smaller sum of money to get them through the tendering stage. We are determined to get as many third sector organisations as possible winning contracts to deliver public services, and we feel this new Fund is one way we can help."

Rural Business Start-up Programme (RBSUP)

RBSUP is a grant programme targeted at new rural enterprises and young businesses where the investment will help to kick-start the business. Grants of up to £10,000 are available and can cover 40% of the costs of a proposal.

Business Link Yorkshire will establish a panel in order to review and approve RBSUP grant applications from rural businesses/pre-starts. Membership of the panel will include representatives from across Yorkshire and Humber from a variety of organisations where the rural agenda is a priority. Business Link Yorkshire will facilitate this panel but will not be involved in evaluating applications or approving funding for businesses.

Business Link Yorkshire is looking for volunteers and nominations for panel members who have:

- a keen interest in the development of the rural economy
- knowledge of the challenges and issues that face rural businesses
- awareness of regional and national policy on rural affairs
- responsibility within their current organisations for rural issues previous experience of participating in a rural panel would be desirable

In general we are looking for members that have a broad knowledge of rural business issues

Please note

The panel will meet once a month. In periods of high demand it may be desirable to arrange additional meetings – if so we would ask for volunteers.

Alternatively the panel members may be split into two groups with meetings held in the am and pm.

Panel members will be asked to review and evaluate applications before the meeting. The meeting will be used to review scores, discuss issues and finally approve/reject applications

The panel will meet in person initially and will consider the option of operating remotely

Meetings will take place in a various locations in Yorkshire and Humber. Business Link will use meeting rooms at its Key Location Centres and will review arrangements regularly. The Rural Development Programme for England (RDPE) will enable Yorkshire Forward to deliver around £63 million of investment to our region over the next six years.

RBSUP is a grant programme targeted at new rural enterprises and young businesses (less than one year old) where the investment will help to kick-start the business.

Applications from farms that are diversifying and from essential rural retail businesses will also be eligible.

The package of support provided to an individual business must not total more than £10,000 of grant,



RBSUP cont...

Proposals should focus on innovations, quality, sustainability, added value and the development of improved business processes. Support under the RBSUP can only be provided to a limited number of rural businesses types, these include:

- Farm diversifications – limited to applicants who are from a farm holding and who exercise an agricultural activity on the farm at the time of the application (farm workers are not eligible).
 - Tourism sector – for example small scale accommodation, visitor attractions, recreational infrastructure
 - Micro business – limited to rural businesses with less than 10 FTE, and a balance sheet or turnover of less than €2m, at the time of the application.
- Retail businesses – under the Rural Retail Support Scheme (a Yorkshire Forward pilot project) 17 businesses per year will be assisted with an assessment and grant. Businesses that are the only essential retail service in that rural community will be eligible

Funding will be awarded to proposals that contribute to the key investment priorities at both regional and local levels. Proposals should meet the overall aim of the programme, which is to:

“Encourage the start up and diversification of economic activity in key rural sectors”

Proposals will also have to demonstrate one or more of the following key attributes:

- promote innovation;
 - demonstrate good/high growth potential;
 - promote collaborative actions between businesses and through supply chains;
 - deliver multiplier effects, such as wider public ‘goods’ and benefits;
 - provide high quality employment opportunities;
- develop a skilled and adaptable rural workforce.

Small Sparks

Small Sparks is a small grants programme that helps people to do new and exciting things in their community. People have great ideas and mostly they don't cost very much money. They just need a little spark, a little support and then – stand well back!

Small Sparks projects work like this

To run a project you need:

- to match up to £250 funding – it could be with your own time
- an idea
- a plan to involve local people
- to complete the project in 8 weeks
- to keep a record – maybe in photos
- to come and tell people about your project at a celebration.

It's that simple. **Everyone can get involved.**



Small Sparks cont...

If you are a local organisation or a local authority and would like to run a Small Sparks programme, you need to:

- raise a small amount of money – £2500 will fund at least 10 projects. Local companies, public agencies, housing associations, and community groups may have small amounts to contribute
- advertise the programme – organise an event, or produce a flyer
- get people to apply – you don't need forms. People could just turn up and tell you their plans
- discuss the idea – sometimes people need a little nudge and encouragement. Lots of first ideas don't quite work out. That's just life
- give them the money – they sign a receipt and pledge to use it for a Small Sparks project (you may want to discuss where they are going to keep this, or who is going to help them look after it)
- organise a celebration event – this could be all the
- Small Sparks projects together or a celebration of one project in the locality where the project takes place
- tell in Control about the projects.
