The South Yorkshire Community Foundation is the region's spearhead for the national £130 million 'Grassroots Grants' scheme. Grassroots Grants, which is funded by the Office of the Third Sector will run for three years and is split into two parts, an £80 million small grants fund, and £50 million endowment challenge.

Through the small grants fund the Foundation is able to distribute grants of £250-£5000 to small grassroots community groups in Barnsley. £334,095 is available between now and March 2011.

Autumn Watch on your doorstep - New members invited.....

The Rotherham and District Ornithological Society (RDOS) was formed in 1974 to promote an interest in wild birds through discussion, public lectures and field meetings. In addition, a Charity Fund was created and RDOS has raised tens of thousands of pounds towards local and national wildlife conservation projects since its formation.

Working closely with local government, RDOS has conducted surveys and provided information to assist with a variety of local environmental issues, planning applications and land management for the benefit of wild birds and wildlife in general. RDOS fully supports the work of the British Trust For Ornithology and the RSPB and has carried out Common Bird Census, Farmland Bird surveys and Winter Wildfowl counts in the Rotherham area on a regular basis.

Whilst the area for recording counts of birds remains within the borough of Rotherham, membership is open to anyone with an interest in wild birds and



wildlife and there are a wide range of activities for members to enjoy. As well as regular field meetings and trips, RDOS arranges 8 indoor meetings each year with professional speakers from around the UK.

RDOS field meetings and indoor meetings are open to newcomers, where a warm welcome is assured; there is no charge for going along and seeing what the group is about. If you do decide to join, you can do so at a field meeting or indoor meeting and the subscription currently stands at £10.00 per year for adults.

Legal Update from our Advice Team

Protecting workers and businesses

Business groups, unions and the government joined forces from 5th November for the first meeting of the **Fair Employment**

Enforcement Board

The Board will lead the fight to protect vulnerable workers from the minority of unscrupulous employers who exploit their staff and undercut their competitors. Employment Relations Minister Pat McFadden said:

"Workers in the UK enjoy better rights than in the past, but there are still some unacceptable cases of rogue employers mistreating their staff.

"We must safeguard workers rights and ensure unscrupulous employers cannot prey on those who are desperate to earn a living in difficult times.

"Denying workers basic rights on wages, leave and conditions is not only illegal, but cheats the majority of honest businesses. These practices must be stamped out." The new Board brings together government enforcement bodies, unions, business leaders, and Citizens Advice to ensure effective enforcement of the law.

ACAS code of practice on disciplinary and grievance procedures

The final version of the revised ACAS Code of Practice on Disciplinary and Grievance procedures was issued on 7 November for parliamentary approval. It comes into effect from 6 April 2009 to replace the statutory disciplinary, dismissal and grievance procedures. ACAS has also issued a detailed guide to what has changed since the earlier (consultation) draft of the code. An unreasonable failure by an employer to follow the Code will result in a



tribunal having the power to increase any award by up to 25%.

The current version has the word 'draft' stamped all over it as it is awaiting approval by parliament - but this should be a formality.

New HMRC Gift Aid Declaration Forms

HMRC have amended their pro forma gift aid declarations to take into account the reduction in basic rate tax to 20p in the £ and transitional relief. Charities may wish to update their gift aid declarations accordingly. It is always worth remembering that wrongly phrased gift aid declarations can be declared as invalid by HMRC and as a result you could be required to repay your gift aid claims back to HMRC!

There should be no need to ask existing regular donors to replace their gift aid declarations with new ones. Declarations that reflect the updated pro formas should only be necessary for donations not already covered by an existing valid gift aid declaration.

IMPORTANT NEWS FROM BATES, WELLS & BRAITHWAITE Community Infrastructure Levy

Quote: "The government is currently attempting to pass legislation which will introduce a new tax called the Community Infrastructure Levy. This tax will be levied on the development of land and buildings – and there will be no exemption for charities. At its worst this new tax could have the effect of preventing charities from developing land or buildings that they own. It will certainly mean that charities will have to find the extra money required to pay the tax through additional fundraising or through their reserves.

In spite of the seriousness of the situation, many in the sector remain unaware of how they will be affected; and others, though aware, have not taken action to try to protect their position.

The legislation is at Committee stage in the House of Lords but time is running out for the Sector to make its voice heard. If you have any contacts in the House of Lords who will support a charity exemption please let us know. Better still contact them direct and ask for their support."
